HIGHLIGHT CORPORATE RESULTS 2023

2023 was the mid-point of implementation of the Cities Alliance 4-year **Strategic Plan 2022-2025: Delivering for the Urban Poor**. The Corporate Scorecard reports against the **Corporate Results Framework**, which has been developed to manage and monitor the implementation of the 2022-2025 Strategic Plan.

HIGHLIGHT RESULTS, 2023

Tier III indicators capture Cities Alliance programmatic outcomes, delivered through technical assistance, policy advice and development, institutional and capacity strengthening, infrastructure development in informal settlements and the mobilisation of domestic and international financial resources for cities.

70 urban institutions (including 19 slum dweller federations) were engaged in capacity strengthening partnerships by Cities Alliance across 24 countries



14,544 individuals participated in capacity strengthening initiatives in 2023, through training, workshops and exchange events



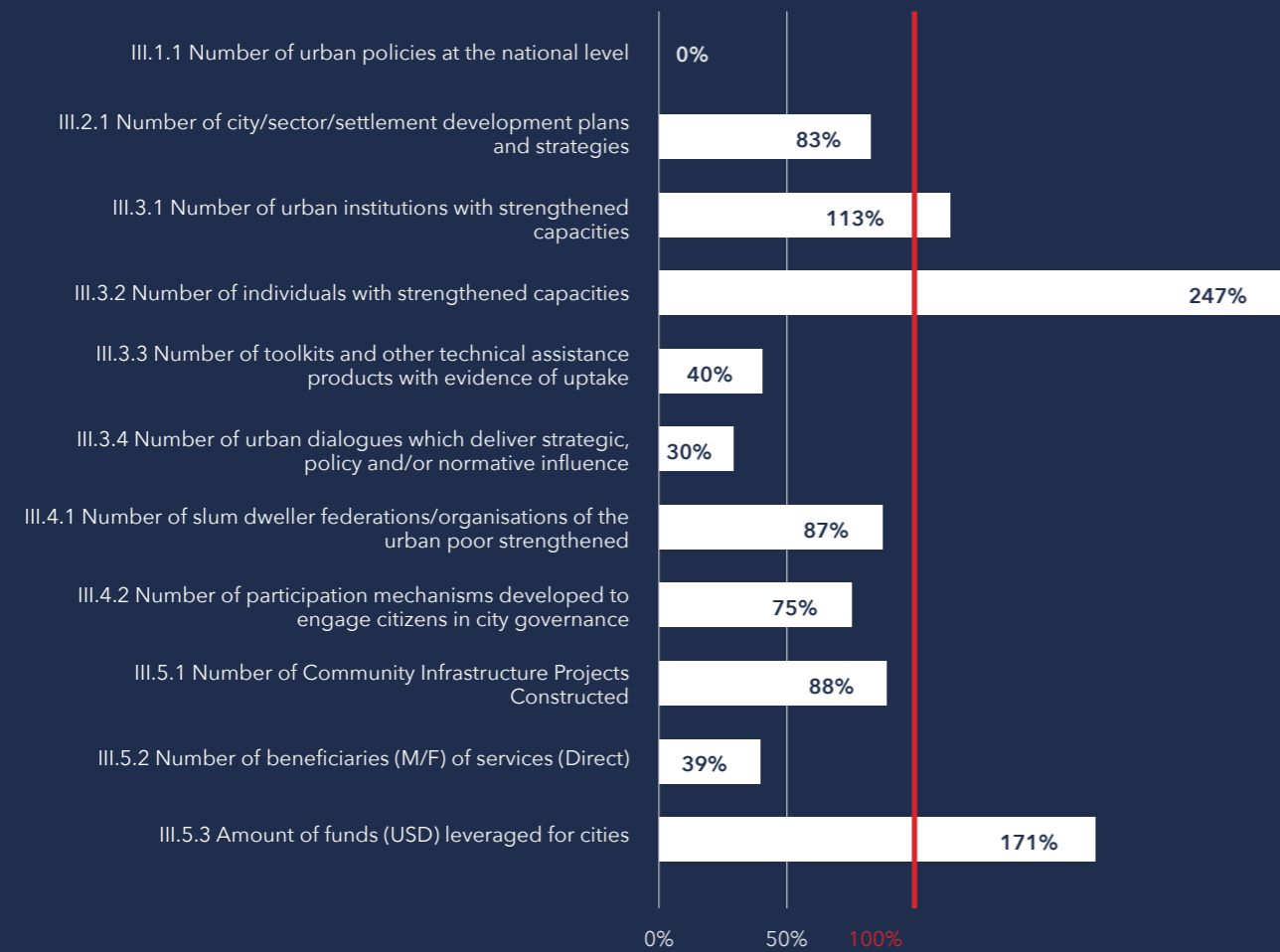
33,584 individuals directly benefited from Cities Alliance services in 2023, including nearly 18 thousand benefiting from the delivery of basic municipal services and training opportunities through the **Phase II Cities and Migration Programme**



Over USD \$12 million in funding for cities was leveraged, including follow up and parallel investments for Haiti, Nepal and the MENA region



Performance against Strategic Plan 2022-2025 Targets



At the midpoint of the strategy, and considering aggregated results from 2022 and 2023, **70% of the total Programme Result indicators appear to be on track for delivery in the remaining two years of the strategic period.** In 2023, five of the nine indicators with 2025 targets have reached at least 75% of the strategic target, and the funds leveraged for cities reached 171% - with a total of over USD \$34 million raised.

- Both indicators with annual targets (III.3.1 Institutional and III.3.2 Individual urban capacities) outperformed the annual target.
- Results against Indicator III.5.2 which measures the beneficiaries of services are underperforming against the strategic targets, however this is anticipated to increase as newer initiatives reach maturity towards the end of the strategic period.
- Indicators III.3.3 Toolkits with evidence of uptake and III.3.4 Influential dialogues, as noted in previous Scorecards, are lagging indicators².
- Cities Alliance has not worked at the national policy level (Indicator III.1.1 National Urban Policy) during these two years, which may reflect a shift in funding from the national level, to corridor, city, and settlement level engagements.

² Learning from the previous strategy (2018-2022) demonstrated that Tier III results for these indicators were delivered in the final years of the strategic period. Similar patterns in results delivery should be anticipated and accounted for in scorecard analysis and interpretation for the current strategy.

SECRETARIAT RESULTS, 2023

Tier IV Indicators track the performance of the Cities Alliance Secretariat in delivering the mission of the Strategic Plan across five different areas: integrated programming, partnerships, volume, efficiency, and sustainability.

100% of active Cities Alliance projects integrate a component or objective on gender equality, climate, youth opportunities or digital solutions, up from 43% in 2022



USD \$1,154,845 in co-financing was raised in 2023



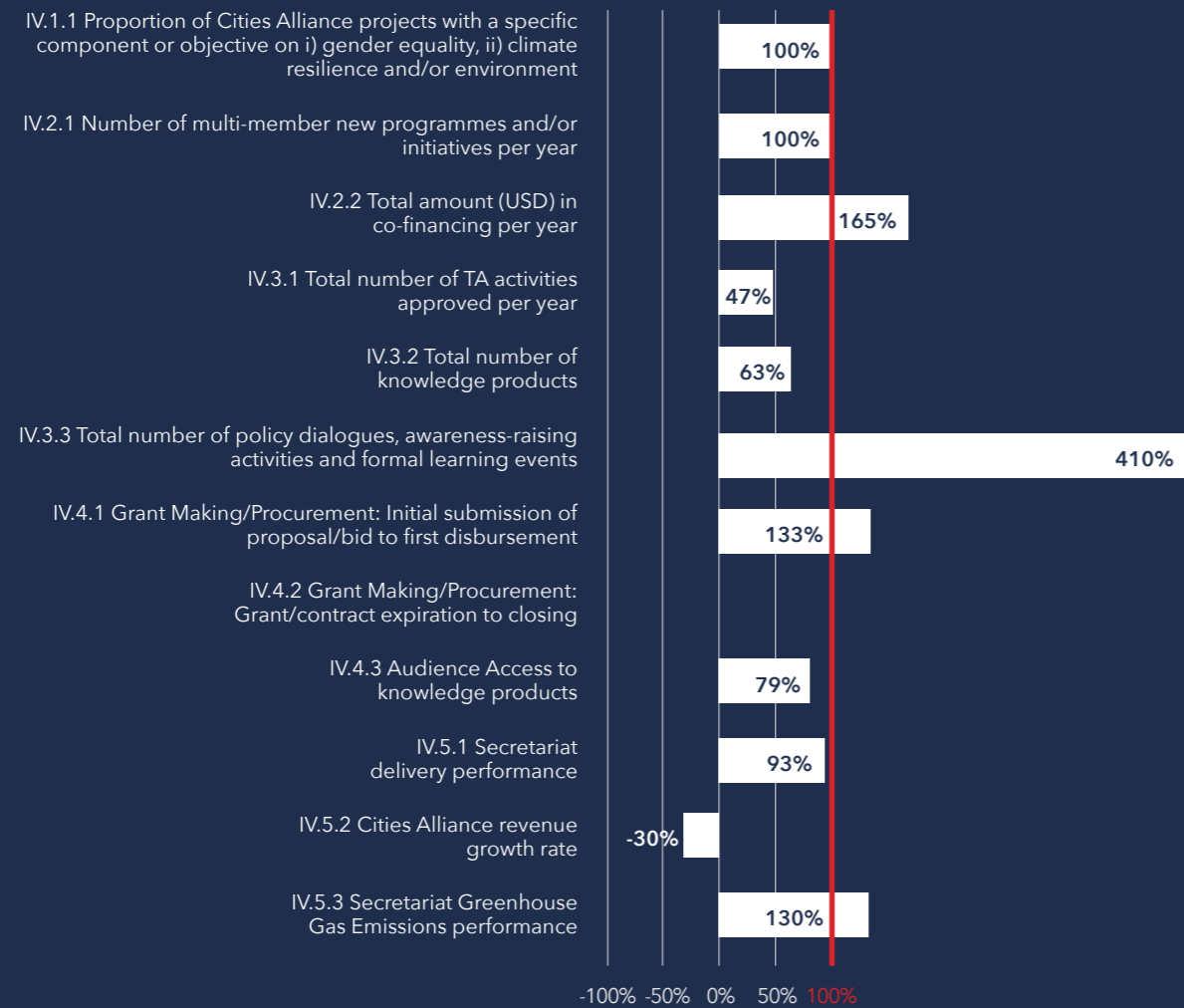
205 policy dialogues awareness-raising activities and formal learning events financed by Cities Alliance were facilitated in 2023

2023 Performance against Annual Performance Standards



Cities Alliance met or outperformed the annual performance standard for 6 of the 12 secretariat indicators and for three of the five performance areas.

- Of note, is the increase from 43% (in 2022) to 100% (2023) in the proportion of Cities Alliance projects integrating gender equality, climate and/or environment, youth opportunities and digital solutions.
- Partnership indicators both met or exceeded targets, whilst the Volume indicators were mixed: the number of TA activities approved fell below the annual standard - reflecting the programmatic position as between project cycles: large programmes on Cities and Migration Phase I and Madinatouna II in Tunisia closed in 2022, and the new portfolio including the programmes in Haiti and Nepal are in early stages of implementation.
- Significant results for the policy dialogue, awareness raising and formal learning events indicator were delivered at multiple levels - from global events to the city and settlement level.
- In 2023, performance against indicators of Sustainability were undermined by the revenue growth rate, which turned negative in 2023.

There were no national urban development policies developed or updated in 2023.

2023 result: 0 Performance towards 2025 target: 83%

There were no city/sector/settlement development plans and strategies developed or updated in 2023.

Number of urban institutions with strengthened capacities



2023 result: 70 Performance towards 2025 target: 113%

Institutions supported with capacity strengthening in 2023 mainly included national ministries, municipalities, NGOs, implementing partners, research and academic institutes, and several international organisations.

The main focus areas targeted through institutional capacity strengthening in 2023 was Gender Equality and Inclusion with at least 46 institutions strengthened under that theme. Other topics for institutional strengthening included Climate Change, Local Economic Development and Migration Management.

All 70 institutions continued the institutional strengthening process into 2024.

Number of individuals with strengthened capacities



2023 result: 14,544 Performance towards 2025 target: 247%

In 2023, Cities Alliance delivered capacity development interventions to over 14,500 individuals through multiple trainings, workshops, and events.

The SDI Covid Recovery Programme, the Gender Programme and the Phase II Cities and Migration Programme are the main contributors to these 2023 results.

Number of toolkits and other technical assistance products with evidence of uptake by stakeholders and/or beneficiaries



2023 result: 2 Performance towards 2025 target: 40%



In partnership with the World Bank, Cities Alliance published the Migrants, Markets and Mayors report, which reviews how secondary towns and cities in Africa can better prepare for and manage the internal economic migration of workers to the mutual benefit of cities and migrants alike. The report was widely disseminated on global platforms including through the Agence Française de Développement (AFD).

The Cities Alliance new Her4Water tool aims to assess women's vulnerability to water scarcity and engagement in water governance. The tool has been widely disseminated and was applied in each project city of the Women and Sustainable Cities Programme in the MENA region (Morocco, Mauritania, Tunisia).

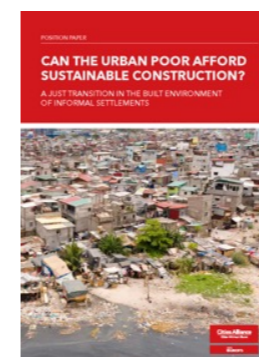
Number of urban dialogues which deliver strategic, policy and/or normative influence i) globally, ii) nationally, iii) within cities



Results 2022: 4 (3 global, 1 national) Performance towards 2025 target: 30% (200% global, 33% national)

Building off the multi-year dialogue facilitated through the Cities Alliance Informality Task Force, in 2023 Cities Alliance partnered with UN-Habitat to implement the framework for the Global Action Plan: Accelerating for Transforming Informal Settlements and Slums by 2030 (GAP). The GAP aims to enhance conditions in informal settlements with essential services such as water, sanitation, electricity, and transport, acknowledging them as human rights issues.

In 2023, following the Arua city initiative and strategic advocacy efforts at the national and global levels, the Ugandan government decided to enumerate urban refugees across Uganda in its 2024 national census. The Arua city initiative of the Cities and Migration Programme forged a partnership with the Uganda Bureau of Statistics (UBOS) for a first-time survey on urban refugees in a secondary city. The Programme further prepared a Policy Brief for an advocacy campaign and began to convene local governments from the West Nile region of Uganda and international actors, which have turned their attention to urban forced displacements. Across the municipalities in the West Nile region, an alliance has formed to advocate for a reconsideration of the national policy on refugee registration, which shall go beyond registrations in camps/settlements and Kampala city.



Under the Climate Change Programme, Cities Alliance has been fostering an ongoing dialogue on the topic of sustainable construction. Cities Alliance coordinated members and stakeholders of the Sustainable Construction Working Group which jointly produced the position paper "Can the Urban Poor Afford Sustainable Construction?" and which was circulated by Cities Alliance and its partners such as ICLEI, ORG Permanent Mobility and others.

The ongoing Cities Alliance collaboration with UNOPS on gender and inclusion has contributed to enhanced cooperation and greater prominence of gender initiatives within UNOPS. This includes further integrating gender perspectives into project planning and execution at the program level, and cultivating broader partnerships and bolstering outreach to tackle gender inequalities. Specific UNOPS offices, including those in North Africa, Ukraine, Europe, and Nepal, have collaborated with Cities Alliance to design projects with a gender focus and to gain insights into relevant tools and methodologies.

Number of slum dweller federations / organisations of the urban poor strengthened



Results 2022: 1 **Performance towards 2025 target: 87%**

In addition to the new organisation reported for 2023, 18 of the 25 reported strengthening interventions in 2022 are still in progress in 2023. These include the SDI affiliates supported through the **SDI Covid Recovery Programme**.

Number of participation mechanisms developed to engage citizens in city governance



Results 2022: 4 **Performance towards 2025 target: 75%**

Of the 14 mechanisms reported in 2022, 13 are still in progress. New mechanisms established in 2023 include inclusive processes in 4 cities in Tunisia, Morocco and Mauritania, which aim to integrate gender-responsive approaches to urban planning.

Number of community infrastructure projects constructed

Results 2022: 2 **Performance towards 2025 target: 88%**

In 2023, two community infrastructure projects were delivered through the **Cities and Migration Programme**: a migration registration centre in Adama, Ethiopia, and an ultrasound service provision centre in the West Nile region of Uganda.

Number of beneficiaries (M/F) of services (Direct)

Results 2022: 33,584 **Performance towards 2025 target: 39%**

Services provided by Cities Alliance benefitted a total of 33,584 individuals in 2023:

- The **Cities and Migration Programme** benefitted 17,921 individuals from migrant, forcibly displaced and vulnerable host communities groups. The action was twofold: the delivery of basic municipal services and specialised training intending to enable beneficiaries to access new or better economic opportunities.
- Through the **SDI Covid Recovery Programme**, another 14,061 individuals strengthened their tenure as Cities Alliance worked with local SDI affiliates to support mass land regularisation and secure title deeds in Malawi and Zambia.
- In the MENA region, the **Women and Sustainable Cities Programme** benefitted over 1,000 people, through activities including capacity interventions.

Amount of funds (USD) leveraged for cities



Results 2022: \$12.28M **Performance towards 2025 target: 170%**

In 2023, Cities Alliance leveraged over USD \$12 million under the following programmes:

- The Cities and Migration programme attracted USD \$1,155,000 of co-funding in 2023.
- USD \$4,282,056 was leveraged through the Gender programme: the EU Delegation in Nepal funded the Cities for Women initiative in the country and the French ministry for Europe and Foreign Affairs funded the Women and Sustainable Cities programme in Tunisia, Morocco, and Mauritania.
- USAID provided USD \$6,840,303 for the **LAVIL Programme** in Haiti.
